## Wearable Art Competition Rules

Please Read Carefully

1. Open to all, but must be the work of the person or group applying to the competition. Limit of 2 entries per person or group. Family members/permanent employees of show management or sponsors are not eligible. Garment(s) must be constructed by person(s) named on entry blank.
2. Full ensembles or individual articles of wearable art (a vest, jacket or coat) may be entered in the competition. No items constructed from kits are allowed.
3. Category definitions: Individual article: a vest, jacket or coat. Full ensemble: garment or group of garments that need no other items to make it ready to wear in public. Examples: suit ensemble, dress, evening gown or pants outfit.
4. Garments winning cash at Mid-Atlantic Quilt Festival or Pacific International Quilt Festival are not eligible to be judged.
5. Entries must have been finished in 2008, 2009 or 2010 and be in excellent condition.
6. Amateur entries are defined as entries created by persons who have never taught wearable art or clothing construction for a fee, published books on the subject of clothing or wearable art, made money from their wearable art through selling, designing or stitching or won prize monies at a wearable art competition.
7. Entry must have a cloth label (on each piece of full ensemble) with the name, address and telephone number of the entrant securely sewn to the inside.
8. Ship the entry in a secure carton. Place the item(s) in a sturdy plastic bag. *Do not use Styrofoam or cellulose "peanuts."* Put name, address and phone number on each bag. Cost of return shipping and insurance in return transit will be the responsibility of show management. Original carton will be used to return the item via UPS or other designated carrier. Please remove all old shipping labels from the carton prior to shipping.
9. Entries must be available for display at Pacific International Quilt Festival, October 14-17, 2010, at the Santa Clara Convention Center, Santa Clara, California.
10. If an entry is to be hand-delivered to the festival and/or personally picked up from the festival, the show management must be notified in writing prior to September 24, 2010.
11. If an entry is to be return shipped to an address other than the one listed on this form, show management must be notified in writing of this change prior to September 24, 2010. All foreign entries must be return shipped to their point of origin.
12. If accepted, slides/digital images and photographs taken become the property of David M. & Peter J. Mancuso, Inc. for publicity and/or publication use.
13. Prize winners will be notified within 10 business days. Viewers' Choice will be presented at Show & Tell on Saturday, Oct. 16, 2010.
14. Filing of your signed application signifies agreement with these conditions.
15. Judges reserve the right to not award a prize in a given category if there are insufficient entries in a specific category.
16. The awarding of any prize makes the entry ineligible for any lesser prize. Viewer's Choice award is exempt from this rule.

## To Enter - Send:

- A. Completed entry form with a non-refundable entry fee of \$20.00 per garment. **IMPORTANT:** Please make check payable to Mancuso Show Management.
- B. Three color slides or digital images (front view, back view and close-up of garment) submitted on a CD. Identify each slide or CD with your name and title of garment. CDs and slides will not be returned.
- C. **IMPORTANT:** A business-size, #10, Self-Addressed Stamped Envelope (44 cents postage).

## Garment Return

Entries will be returned via United Parcel Service (or other designated shipper) within 48 hours of close of the Festival. Cost of the shipping will be paid by PIQF. Items will be insured for \$500 US each on return shipping. Management reserves the right to delay the return shipment of winning entries for up to ten (10) business days for the purposes of professional photography.

**Important Note:** Foreign entries **MUST** be shipped to the event only via the PIQF designated carrier. (Complete information will follow upon acceptance.)

## Contest Calendar

### August 25, 2010

Entry form, business-size SASE, slides/digital images and non-refundable entry fee for each item entered must be received or postmarked no later than **August 25, 2010**.

**ENTRY FEE** (domestic and foreign entries): \$20.00 US, includes return shipping. Note: All foreign payment must be International Postal Money Order made out in US dollars or VISA/MasterCard.
